The Business Committee is subordinate to the General Council and cannot override or disregard the General Council and its directives or resolutions. AND Article IV of the Constitution – Membership of the Council, was also read aloud in reference to this resolution Wording in resolutions not necessarily what will be put in the Constitution, may be better addressed by similar measure such as Tribal Legislation hierarchy as discussed at November 20th 2023 meeting Necessary to discuss this with all members of Committee present, the two legal professionals on the Committee are key to proper implementation
